NOTIFICATION

Whereas, orders were issued in the reference 1st read above, declaring any services in Telangana State Power Generation Corporation Limited as an essential service under the provisions of the Telangana Essential Services Maintenance Act, 1971, (A.P. Act No.20 of 1971)

2. And whereas, the Government is satisfied that it is necessary and expedient to prohibit strikes in public interest, in all services under Telangana State Power Generation Corporation Limited for a further period of six (6) months w.e.f 27.07.2019.

3. Now, therefore, in exercise of the powers conferred by sub-sections (1) and (3) of section 3 of the Telangana Essential Services Maintenance Act, 1971 (Act 20 of 1971), the Government of Telangana hereby prohibits strikes in all the services under Telangana State Power Generation Corporation Limited for a period of six (6) months with effect from 27.07.2019.
